OFFICIAL TIME FRAME FOR THREE (3) POSITIONS TO SERVE FOUR (4) YEAR TERMS

LITTLE WOUND SCHOOL SERVICE AREA POLLING SITES OPEN FROM 9:00 AM – 7:00 PM

KYLE CAP, MEDIATOR CHURCH, POTATO CREEK-ST-HENRY'S, ALLEN CAP, BATESLAND COLLEGE CENTER, WAKPAMNI LAKE, PORCUPINE CAP, MANDERSON CAP, WOUNDED KNEE CHURCH, MARTIN CAP, SHARPS CORNER BAPTIST CHURCH, AND WANBLEE.

Petitioners must pick up and return their own petition. Petitioners are required to pay for their own background checks. A blank \$26.75 money order and a blank \$5.00 money order for finger printing and background check must be taken to the Pine Ridge OST Public Safety Building.

A blank \$20.00 money must be taken to OST Pine Ridge Court House for Tribal background check.

The School also requires a drug test to be done by each Petitioner, a \$35.00 money order will need to be taken to the LWS Business Office and drug test completed onsite by one of the nurses.

Due to the high volume of elections being conducted reservation-wide, please complete your requirements immediately.

OCTOBER 29, 2018

**Post Sample Ballots in the LWS election service areas.
Absentee voting begins.**

NOVEMBER 5, 2018

Deadline to cast absentee ballots at LWS Business Office no later than 4:30 PM (MST).
